- 1. Observer Appointment Criteria:
 - Should be member of the executive committee of SGFI

- Should be experience officer holding a Rank no lower than class 1 position OR
- Dy Director Sports/Education from affiliated units

 Should have represented India in Olympic/Asian/Commonwealth Games (Player)

OR

 A senior person with minimum 15 years of experience in sports administration

Job Responsibilities

- Oversee the overall conduct of the national championships to ensure compliance with SGFI rules and regulations
- Monitor and evaluate the performance of technical and field officers
- Ensure fair play and adherence to the spirit of sportsmanship throughout the event
- Mediate and resolve any disputes or conflicts that may arise during the championships

2. Technical Chairman/Officer Appointment Criteria:

- Sport-specific certification from a recognized national or international body or attended technical workshop of SGFI
- Minimum 10 years of experience as a coach, referee, or technical official (ITO/NTO- International/National) in the relevant sport
- Qualified National/International referee in specific game
- Up-to-date knowledge of international rules and regulations for the specific sport

Job Responsibilities

- Oversee the technical aspects of specific sport during the national championships
- Ensure proper implementation of sport-specific rules and regulations

- Coordinate with venue management & SGFI office to ensure proper setup and maintenance of competition areas
- Oversee athlete registration, accreditation, and participation
- Manage the competition schedule and ensure timely execution of events
- Coordinate with local authorities for security, medical, and other support services
- Supervise volunteer management and training

- Represented as in coach or Assistant coach for Indian team for the same game
- Familiarity with modern athlete development pathways and selection methodologies

- Develop and implement fair and transparent selection criteria for national teams
- Observe and evaluate athlete performances during the national championships
- Conduct talent identification programs
- Select athletes to represent India in international school sports competitions
- Provide feedback to athletes & coaches on selection decisions

- Review and update selection policies regularly to align with international standards
- Maintain detailed records of athlete performances and selection rationales
